1.3 Approval of the October 16, 2023 Regular Meeting Minutes

3. REPORTS

3.1 Caltrans

Michael Oguro provided an update to the Commissioners. There were not substantive changes to the projects currently of interest in the Region. Commissioners reminded him that there are a number of county roads (A3 for example) that are used as cutoff roads for the State Highway System and therefore receive unusually large amounts of heavy truck traffic. They reiterated their desire to either have the roads taken over by the state, or receive some funding to support maintenance for these roads. Mr. Oguro said he would look into it.

Mike also provided a follow-up for a question about traffic numbers on SR 139 and how Caltrans developed that information. Mike provided an overview of their traffic count system. There had also been a specific question about Johnstonville School Road, and speed limit enforcement at and near the school. Mike confirmed that a

speed study had not been done in some time, and that it was difficult to enforce speed laws (except in school zones) if a study had not been done recently.

3.2 CHP

Jason Grimm reported on CHP activities in the region including enforcement contacts, citations, warnings, DUI stops, and DUI collisions. He noted that of the 18 collisions investigated by CHP that 7 were solo wrecks. Commissioner Neely asked if they had noticed any increase in collisions with deer near the CHP office. He noted that they had not

3.3 City of Susanville

Pete Heimbigner introduce Jasleen Mutti recently hired into the public works department. Among her tasks Ms. Mutti will be taking over transit planning for the county.

4.10 Action/Discussion Items

4.11 Zero Emission Vehicle Infrastructure Feasibility Study Progress Presentation

Analy Castillo of Stantec, and the Project Manager for the Zero-Emission Vehicle Infrastructure Feasibility Study (ZEV Study), provided an update on study progress, analysis to date, anticipated outcomes, and next steps to completion. She confirmed that the study would be done early in 2024. Here update included the purpose for the ZEV Study, including interactions with California Air Resources Board (the entity requiring the study) staff, project phases, key findings from existing conditions, constraints unique to Lassen County, and next steps.

The update included an overview of the analytical tools used, and how they were applied to the existing transit systems operations and plans for fleet development.

In addition, Ms. Castillo provided the schedule for the CARB Mandated transit vehicle conversion, and noted that although the LCTC was out of compliance with the deadline for developing the current study, staff had requested and received a waiver.

Important takeaways from the presentation and next steps. Hydrogen Fuel Cell vehicles which were originally part of the study were eliminated early on as infeasible. Current analysis indicate that the current status of EV transit bus development will not work in the environment that the transit provider operates in. For example there are not EV transit vehicles that come equipped with automatic chains which is critical when operating in an environment where it occasionally snows.

Commissioners voiced their skepticism about using EV's in the cold, mountainous a region. One commissioner questions the need to do the study. The Executive Secretary responded that it was required by CARB. He added that by using the tools recommended by CARB for the assessment, and those tools showing the infeasibility of beginning the conversion to EV transit vehicles, the region will have a strong argument to make against conversion at this time.

This was an information item. No action was required from the Commission.

4.12 Final Lassen County 2023 Regional Transportation Plan

The RTP serves as the planning blueprint to guide transportation investments in Lassen County involving local, state, and federal funding over the next twenty years. Transportation improvements in the RTP are identified as short-range/constrained (2023-2033) or long-range/unconstrained (2034-2044). The RTP must be updated every five (5) years to comply with Caltrans guidelines and be eligible for many sources of funding. The last RTP update was adopted in 2017. Any transportation capital improvement projects funded with state or federal funds must be identified in the RTP.

Genevieve Evans, Project Manager for the update, reported that at their October Regular meeting, the Commission received an in-depth review of the RTP and the year-long effort to update the document. Since then, LCTC staff have completed the Final Lassen County 2023 Regional Transportation Plan and Initial Study Checklist/Proposed Negative Declaration. The Draft RTP was presented at the October 10th meeting for review and discussion. The RTP and Environmental Document were available for review and comment from October 6 - November 6 and circulated through the State Clearinghouse as required. Comments received on the Draft RTP and Environmental Document have been incorporated into the Final RTP.

Ms. Evans noted that since the draft RTP was circulated they had received comments from Lassen County and the public. Most of these comments helped fill in information in the RTP but had not changed the overall scope or vision of the document. She also

reported that the California Department of Fish and Wildlife had commented on the environmental document requesting that we pay special attention to wildlife crossings on major highways. These comments did not require recirculating the environmental document.

The Commissioners were asked to Adopt by separate motion the 2023 Regional Transportation Plan and Environmental Document.

It was moved by Commissioner Gallagher and seconded by Commissioner Neely to adopt the Environmental Document prepared for the 2023 Lassen County Regional Transportation Plan. The motion was passed by the following vote:

Commissioner Albaugh had concerns about the language stating that Lassen County supported the states GHG and climate change goals. He asked that they be removed or rewritten. The Executive Secretary noted that in order to get funding some mention of the states priorities would need to be in the document. He feared that by rejecting them the document would not be accepted by the state, and would disqualify the county from receiving state and federal funds. He stated that staff could work with Caltrans staff to develop language that would meet the Commissions views, but also not jeopardize future funding.

The Commission agreed to table adoption of the 2023 RTP to the December meeting, pending the revision of the language regarding the states GHG and climate change goals.

4.13 Senate Bill (SB) 125 Transit and Intercity Rail Capital Program / Zero Emission Transit Capital Program – Overview and Discussion

Senate Bill 125 (SB 125) amended the Budget act of 2023 to create a new one-time source of transit funding to address operational funding shortfalls created from the reduction in transit ridership during the COVID-19 pandemic and capital needs. Approximately \$5.1 billion of funding will be distributed by formula over four years and administered by Regional Transportation Planning Agencies (RTPAs), such as the Lassen County Transportation Commission (LCTC) to identify and program regional transit operations and capital projects. SB 125 is being implemented by the California State Transportation Agency (CalSTA).

The Executed Secretary provided an overview of SB 125, its major funding elements, how they apply to Lassen County transit, and potential uses for the money regionally. He updated them on staff discussions with CalSTA staff, Lassen Rural Bus, City and County staff, tribal representatives, and the public. He noted that the funds (thought

programmed for four years) can be spent beyond that deadline, there was significant flexibility to change plans as situations dictate, and that there would likely be follow up measures to fund transit beyond SB 125.

An allocation plan for these funds is due to CalSTA by the end of December. An outline of funding priorities will be brought to the Commission for approval at their December meeting.

This was an information item. No action was required from the Commission.

- SB 125 This is a new program to help fund transit in the wake of use changes as a result of covid and other work from home activities. There is significant funding available to Lassen County (\$4.1 million) to assist transit operations and capital investments. Staff, working with the LTSA, will prepare an application to secure the funding. Applications are due to the state by December 31.

PAST ACTION & DISCUSSION

At your May 5, 2023, Regular Meeting you approved the FY23/24 Overall Work Program and Budget (OWP) for the Lassen County Transportation Commission. The OWP was subsequently received and approved by Caltrans and notification of such was sent to the Executive Secretary by email on June 22, 2023.

At your November 13, 2023 Regular Meeting, you approved Resolution 23-12 amending your FY 2023/24 OWP and Budget. The primary reason for the amendment was to include WE 706 the Lassen GIS Plan, funding for which was approved by Caltrans after your May meeting. In addition, Resolution 23-12 recognized and programmed \$3,500 of Rural Planning Assistance Carryover from FY 22/23. Staff later determined that the actual amount of RPA Carryover was \$10,543.86, a difference of \$7,43.86. Action by the Commission on this will rectify the difference and allow staff to allocate the funds within the amended OWP.

In addition, it was determined that there was \$99,755.78 associated with the WE 706 ZEV Infrastructure Feasibility Study that needed to be programmed by resolution as well before being applied to the FY 23/24 OWP and Budget. The resolution addresses that as well.

BACGROUND & DISCUSSION

On June 19, 2023, the Commission approved Resolution 23-09 which among other things allocated funding to the LTSA for transit operations during FY 23/24. Subsequent to this, available funding has changed necessitating a revision to the June allocations.

In FY 22/23 the LTSA's transit system operational expenses were budgeted at \$1,664,080. This year, FY 23/24, the operational expenses are \$1,794,245. Over the last 5 years, the operating expenses have increased 48%. The major funding sources to cover these expenses has only increased 21% over this same period. This year is the first year that a shortfall is foreseen. The total LTF and STA funds for transit during FY 23/24 is estimated to be \$1,073,607. The requested funding is \$1,098,561. Leaving a \$24,954 shortfall.

This is common among transit systems throughout California. As a consequence, SB 125 was approved with the FY 23/24 State Budget allocating additional funds to transit systems. Allocation of SB 125 funds is addressed with agenda item 4.13.

- 2. To the Lassen County Transportation Commission for administration and planning in the amount of \$190,466 per the prior approved Overall Work Plan.
- 3. Reserve 2% of the LTF funds remaining after the overhead, administration, and planning costs (estimated to be \$14,400) for subsequent allocation to the County or the City for purposes of pedestrian and bicycle facilities.
- 4. To the Lassen Transit Services Agency, the estimated total remaining LTF funds available for allocation (\$679,420) for Article 4 purposes.
- 5. To the Lassen Transit Services Agency, the estimated total STA funds available for allocation (\$394,177) for transit operational purposes.

REQUESTED ACTION: By Motion, Adopt the 2023 Regional Transportation Plan

PAST ACTION

At their November 13, 2023 Regular Meeting Commissioners were presented with the Final Lassen County 2023 Regional Transportation Plan (RTP) and Environmental Document (Initial Study) for adoption. This followed several meetings where Commissioners were provided updates on the progress of revising the RTP. The RTP and Initial Study had to be approved under separate motions. At the November meeting, Commissioners adopted the Initial Study, but did not approve the RTP. At that time there were concerns about language stating that Lassen County supported the full range of environmental, air quality, and mobility initiatives promoted in Sacramento.

Staff was tasked with revising this language so that it more accurately reflected the Commissions views, but did not jeopardize the RTP's viability. The revised text is provided in this staff report as Attachment A.

The changes do not substantively affect the RTP and so the previously approved Negative Declaration does not have to be considered at this time.

BACKGROUND/DISCUSSION

One of the major planning responsibilities of the LCTC is the development of the Regional Transportation Plan (RTP). The RTP serves as the planning blueprint to guide transportation investments in Lassen County involving local, state, and federal funding over the next twenty years. Transportation improvements in the RTP are identified as short-range/constrained (2023-2033) or long-range/unconstrained (2034-2044). The RTP must be updated every five (5) years to comply with Caltrans guidelines and be eligible for many sources of funding. The last RTP update was adopted in 2017. Any transportation capital improvement projects funded with state or federal funds must be identified in the RTP.

The overall focus of the 2023 RTP is directed at developing a coordinated and balanced multi-modal regional transportation system that is financially constrained to the revenues anticipated over the life of the plan. The coordination focus brings the County, Caltrans, the City of Susanville, government resource agencies, commercial and agricultural interests, Susanville Indian Rancheria, and citizens into the planning process. The balance is achieved by considering investment and improvements for moving people and goods across all types of transportation including automobiles, public transit, bicycle, pedestrian, trucking, railroad, and aviation.

This 2023 update of the RTP did not significantly change the scope or goals of the prior RTP. Changes to the RTP from the Draft version to the Final version include:

- Highlighting certain active transportation projects deemed particularly important for the region
- Clarified description of the role of the LTSA
- Expanded description of rail and freight
- Clarification of some Caltrans projects
- Updated traffic volume data
- Strengthen discussion on wildlife connectivity concerns as suggested by the US Fish and Wildlife comment letter on the Environmental Document
- A variety of clerical error corrections and clarifications

RECOMMENDATION – Approve the Final RTP as presented by staff.

Climate Change and Resiliency

Goal 7: Reduce GHG emissions from transportation related activities within the Lassen County boundaries to support the state's efforts under AB-32 and to mitigate the impact of climate change.

Policy 7.1: Consider GHG emissions as part of every transportation capital improvement project decision.

RTPAs that are not located within the boundaries of a metropolitan planning organization (which LCTC is not) are not subject to the S375 provisions, which require addressing regional GHG targets in the RTP and preparation of sustainable community strategies. As traffic volumes are generally low in the region, Lassen County is not a significant contributor to GHG emissions. Regardless, this RTP identifies improvements to bicycle and pedestrian facilities that will encourage residents and visitors to use alternatives to private vehicles for transportation, thereby helping to reduce GHG emissions.

With Changes:

RTPAs that are not located within the boundaries of a metropolitan planning organization (which LCTC is not) are not subject to the SB375 provisions, which require addressing regional GHG targets in the RTP and preparation of sustainable community strategies. However, in order to comply with the statewide standards and goals related to climate change, this RTP identifies strategies that encourage emission reduction, including improvements to bicycle and pedestrian facilities that will encourage residents and visitors to use alternatives to private vehicles for transportation.

Original in Negative Declaration

Discussion: As the RTP projects focus primarily on the improvement of existing roadway facilities, the potential for significant impacts on utilities and service systems is low. Any RTP projects that expand transportation facilities include passing lanes or new bike/ped paths and it is unlikely these projects would have an impact on utilities. RTP projects could have direct impacts on utilities or service systems, during project construction on a project-specific basis. The statewide transition to ZEVs and LCTC's support of this transition may impact utility systems within the County and any environmental impacts of ZEV infrastructure projects will be evaluated on a project-specific level.

With Changes:

Discussion: As the RTP projects focus primarily on the improvement of existing roadway facilities, the potential for significant impacts on utilities and service systems is low. Any RTP projects that expand transportation facilities include passing lanes or new bike/ped paths and it is unlikely these projects would have an impact on utilities. RTP projects could have direct impacts on utilities or service systems, during project construction on a project-specific basis. The mandated statewide transition to ZEVs for transit operators, including Lassen Rural Bus, may impact utility systems within the County and any environmental impacts of ZEV infrastructure projects will be evaluated on a project-specific level.

REQUESTED ACTION

BY MOTION: Adopt Resolution 23-14 approving the 2024 Regional Transportation Improvement Program (RTIP)

BACKGROUND

The State Transportation Improvement Program (STIP) is a five-year capital improvement program of transportation projects on and off the State Highway System, funded with revenue from the State Highway Account and other funding sources (most notably SB1). STIP programming generally occurs every two years. The programming cycle begins with the release of a proposed fund estimate in July of odd-numbered years, followed by California Transportation Commission (CTC) adoption of the fund estimate in August (odd years). The fund estimate serves to identify the amount of new funds available for the programming of transportation projects.

Once the fund estimate is adopted, Caltrans and the regional planning agencies (the LCTC) prepare transportation improvement plans for submittal by December 15th (odd years). Caltrans prepares the Interregional Transportation Improvement Plan (ITIP) and regional agencies prepare Regional Transportation Improvement Plans (RTIP's). Public hearings are held in January (even years) in both northern and southern California. The STIP is adopted by the CTC by April (even years).

Local agencies work through their Regional Transportation Planning Agency (RTPA), County Transportation Commission, or Metropolitan Planning Organization (MPO), as appropriate, to nominate projects for inclusion in the STIP. In our case the Lassen County Transportation Commission (LCTC) is responsible for working with the City of Susanville, Lassen County, and the Susanville Indian Rancheria, to identify and nominate a list of projects for inclusion in the Lassen County RTIP.

Once projects are programmed, agencies may begin the project implementation process. It is important to note that there are timely use of funds rules associated with STIP projects that are established by statute and outlined in both the STIP Guidelines adopted by the CTC and Chapter 23 of the Local Assistance Program Guidelines.

Locally, the RTIP can include capital projects associated with the state highway system. The Gateway Project associated with US 395 are an example of this type of project, as well as capital overlay projects on local streets and roads. Any project that is nominated through the RTIP/STIP process must be consistent with the Lassen County Regional Transportation Plan.

Over the past four months Commission staff has met with City of Susanville, Lassen County, Caltrans and CTC staff to determine the best mix of projects to be included in the 2024 STIP. This has included detailed re-evaluation of projects being carried over from the 2022 STIP, and potential new projects to be nominated as part of the 2024 cycle. Caltrans District 2 staff have been consulted to make sure that our actions conform to the most current STIP guidelines.

Projects implemented from the 2022 STIP include:

- County Rehab Project B
- County Rehab Project C
- City Rehab Project FD

This represents an investment in excess of \$5,000,000 in STIP funding for the region.

DISCUSSION

The draft 2024 Regional Transportation Improvement Program is ready for your review and adoption. As mentioned, it is the result of extensive discussions between your staff, the City of Susanville, Lassen County, Caltrans and other regional stakeholders.

The current programming target for either augmenting or new projects for the 2024 STIP is \$6,550,000. The current requests for either augmentation to currently programmed project or implantation of new projects is \$5.7 million. In addition, LCTC staff is requesting \$320,000 of new programming of PPM funding during this STIP cycle. This will leave a balance of \$530,000 to carryover to the next STIP cycle, or to accommodate changes in currently programmed projects as needed.

The following are the highlights from the 2022 RTIP:

- o Programmed \$2,015,000
- o Requested action Combined with County Rehab D as described above.
- Planning, Programming & Monitoring (PPNO 02-2124) Used primarily for staff to fund development of new projects, planning and other transportation work as needed.
 - o Programmed FY 24/25 \$40,000, FY 25/26 \$40,000
 - o Requested action Increase allocation for FY's 24/25 and 25/26 to \$80,000. Program FY' 26/27 through FY 29/29 at \$80,000 per year.

REQUESTED ACTION By Motion, Adopt Resolution 23-13 allocating \$3,663,737 in Fiscal Year (FY) 2023/24 and FY 2024/25 Transit and Intercity Rail Capital Program Funds (TIRCP) and \$442,960 in FY 2023/24 & FY 2024/25 Zero Emission Transit Capital Program Funds (ZETCP) to the Lassen County Transportation Commission on behalf of the Lassen Transit Services Agency (LTSA)

BACKGROUND

The Transit and Intercity Rail Capital Program (TIRCP) was created by Senate Bill (SB) 862 (Chapter 36, Statutes of 2014) and modified by SB 9 (Chapter 710, Statutes of 2015), to provide grants from the Greenhouse Gas Reduction Fund (GGRF) to fund transformative capital improvements that will modernize California's intercity, commuter, urban rail systems, and bus and ferry transit systems, to significantly reduce emissions of greenhouse gases, vehicle miles traveled, and congestion.

AB 102 (Chapter 38, Statutes of 2023) and SB 125 (Chapter 54, Statutes of 2023) amended the Budget Act of 2023 to appropriate \$4,000,000,000 of General Fund to the TIRCP over the next two fiscal years as well as \$910,000,000 of GGRF funding and \$190,000,000 of Public Transportation Account (PTA) funding over the next four fiscal years to establish the Zero-Emission Transit Capital Program (ZETCP). SB 125 provided additional direction with regards to the funding appropriated in the Budget Act of 2023. It created specific categories for funding as follows:

1. \$3,995,000,000 over the next two fiscal years (FY 2023/24 and FY 2024/25) shall be distributed pursuant to a population-based formula to regional transportation planning agencies (RTPA) as defined in Section 7 of these guidelines. The bill authorizes RTPAs to use the moneys for highpriority transit capital projects consistent with the uses allowed in Cycle 6 of the TIRCP, which includes existing projects seeking to maintain or obtain federal or local funding commitments, project development for major projects that are seeking to enter or have already entered project development with federal partners, or for new TIRCP projects. As in Cycle 6, all capital projects must both increase ridership and reduce greenhouse gas emissions, in common with traditional

TIRCP project requirements. The funding may also be used to fund transit operating expenses that prevent service cuts and increase ridership for operators within the RTPA's jurisdiction, subject to compliance with requirements and further detail described in Section 6 of the TIRCP guidelines.

2. \$1,100,000,000 over the next four fiscal years (FY 2023/24 through FY 2026/27) shall be for the establishment of the Zero-Emission Transit Capital Program (ZETCP) and requires funds under the program to be allocated to RTPAs pursuant to a population-based formula and another formula based on transit operator revenues within the jurisdiction of these RTPAs, as specified (the formula described is consistent with the current State Transit Assistance formula). The bill authorizes RTPAs to use the moneys for zero emission transit equipment, including, but not limited to, zero-emission vehicles and refueling infrastructure and, subject to compliance with requirements described in Section 6 of the TIRCP guidelines, to use those moneys to fund transit operating expenditures that prevent service reduction or elimination in order to maintain or increase ridership.

DISCUSSION

Eligible recipients of TIRCP and ZETCP funding are RTPAs, as defined in Section 13987(j) of the Government Code. TIRCP funding will be allocated in both FY 2023/24 and FY 2024/25 to RTPAs according to a population-based formula after each recipient first receives \$300,000 of base funding. ZETCP funding over the four years from FY 2023/24 to FY 2026/27 will be allocated to RTPAs pursuant to a population-based formula and another formula based on transit operator revenues within the jurisdiction of individual RTPAs. This formula matches the approach used to calculate State Transit Assistance (STA) distribution. RTPAs have the discretion to suballocate or distribute funds within their region based on local needs, existing procedures, policies, or priorities, as long as required SB 125 program requirements and goals are met, including addressing how operating needs are expected to be met with SB 125 and/or other resources.

Lassen County Transportation Commission (LCTC) received notification that the TIRCP Final Guidelines were approved on September 29, 2023, confirming the FY 2023/24 and FY 2024/25 TIRCP and ZETCP allocation amounts. As the RTPA, it is LCTC's role to allocate TIRCP and ZETCP funding to each project sponsor under the authority of LCTC. According to the TIRCP Final Guidelines, LCTC's allocation for FY 2023/24 & 2024/25 TIRCP is \$3,663,737 and \$442,960 for FY 2023/24 & 2024/25 ZETCP. Since LTSA is the only transit operator in the LCTC region, staff is recommending the bulk of the funds be allocated to LTSA. These plans have been made in consultation with LTSA staff and utilizing the transit planning documents for Lassen County. Staff may reserve a small amount of funding for special studies as described below.

LCTC plans to use the \$3,663,737 in FY 2023/24 & FY 24/25 TIRCP and \$442,960 in FY 2023/2024 & 24/25 ZETCP funds to deliver four projects that are consistent with TIRCP and ZETCP guidelines and are based on recommendations contained in the Lassen County Short- and Long-Range Transit Plans and the 2023 LCTC Draft Zero Emission Vehicle Infrastructure Feasibility Study. The projects are:

1. Augmentation to anticipated transit operating deficits as described in the Lassen County Transit Plan.

- 2. Implementation of infrastructure described in the Draft Zero Emission Vehicle Infrastructure Feasibility Study.
- 3. Implementation of transit demonstration projects
- 4. Development of a Lassen County EV infrastructure plan for passenger vehicles and trucks

Per the TIRCP and ZETCP guidelines, each RTPA seeking allocation of funding shall complete an Initial Allocation Package by December 31, 2023. Each Allocation Package shall include, as applicable, the following:

- Signed Cover Letter
- Allocation Package Narrative Explanation
- Allocation Package Detailed Project Description
- ZETCP Project Summary Fact Sheet
- Summary Excel table including the proposed uses of TIRCP and ZETCP funds by fiscal year of availability
- Regionally representative transit operator data

LCTC will submit the Allocation Package by December 31, 2023, and the requested funding will be allocated to LCTC no later than April 30, 2024.

NEXT STEPS

LCTC Staff, working with the local transit provider and CalSTA staff will submit a funding allocation package before the December 31, 2023 deadline.

A. Overview and Schedule

Section 1. Executive Summary

For the 2024 RTIP, LCTC will continue prioritizing the completion of previous State Transportation Improvement Program (STIP) funded projects, important to improving mobility, enhancing economic activity and providing for needed road maintenance in the region. Unlike the 2022 RTIP this RTIP will spend a significant portion of the regional share allocated by the CTC. In addition, the LCTC will request that some projects programmed in the 2022 RTIP be merged and moved forward for construction.

This RTIP continues the regional shift from the development of capital projects and focusing more on maintenance of existing transportation infrastructure.

The 2024 RTIP identifies over \$ 10 million of capital improvements on transportation infrastructure (spread over 6 distinct capital projects) during the 5-year programming horizon. For this STIP the LCTC will be increasing programming of Planning, Programming and Monitoring (PPM) to help with the growing demand for general and specific transportation planning and project management across a variety of modes.

Section 3. Background of Regional Transportation Improvement Program (RTIP)

A. What is the Regional Transportation Improvement Program?

The Regional Transportation Improvement Program (RTIP) is a program of highway, local road, transit and active transportation projects that a region plans to fund with State and Federal revenue programmed by the California Transportation Commission in the State Transportation Improvement Program (STIP). The RTIP is developed biennially by the regions and is due to the Commission by December 15 of every odd numbered year. The program of projects in the RTIP is a subset of projects in the Regional Transportation Plan (RTP), a federally mandated master transportation plan which guides a region's transportation investments over a 20 to 25 year period. The RTP is based on all reasonably anticipated funding, including federal, state and local sources. Updated every 4 to 5 years, the RTP is developed through an extensive public participation process in the region and reflects the unique mobility, sustainability, and air quality needs of each region.

B. Regional Agency's Historical and Current Approach to developing the RTIP

The primary planning document which guides transportation planning, investment priorities, and ultimately delivery is the RTP, updated every five years. The RTP illustrates the regional transportation goals, objectives, policies, and performance measures within a fiscally constrained framework of short-term and long-term transportation projects and programs. LCTC staff works very closely with the City of Susanville, County of Lassen, Lassen Transit Service Agency, the Susanville Indian Rancheria, and Caltrans in the development of the RTP.

A Technical Advisory Committee representing the agencies described above was also consulted in developing the RTIP, as were environmental, business, agriculture, and ranching interests. In preparation for each RTIP cycle, LCTC staff works with these partner agencies and groups to prioritize projects, included within the current RTP, for consideration in the RTIP.

Many of the projects submitted in this RTIP have been part of an ongoing planning process, as outlined in the Lassen County Regional Transportation Plan, Active Transportation Plan, and other planning documents and efforts.

Section 4. Completion of Prior RTIP Projects (Required per Section 78)

The 2022 STIP primarily consisted of a mix of partially-funded projects on the state highway system and a number of local street rehab projects. Projects either completed, or that will be completed, from the 2022 STIP include:

B. Community Engagement

Public notices related to the RTIP were posted in August, October, November and December 2023.

The availability of the RTIP promoted projects was announced at the October 16, 2023 Regular Meeting of the Lassen County Transportation Commission. Section 8. Interregional Transportation Improvement Program (ITIP) Funding and Needs

The purpose of the Interregional Transportation Improvement Program (ITIP) is to improve interregional mobility for people and goods in the State of California. As an interregional program, the ITIP is focused on increasing the throughput for highway and rail corridors of strategic importance outside the urbanized areas of the state. A sound transportation network between and connecting urbanized areas ports and borders is vital to the state's economic vitality. The ITIP is prepared in accordance with Government Code Section 14526, Streets and Highways Code Section 164 and the STIP Guidelines. The ITIP is a five-year program managed by Caltrans and funded with 25% of new STIP revenues in each cycle. Developed in cooperation with regional transportation planning agencies to ensure an integrated transportation program, the ITIP promotes the goal of improving interregional mobility and connectivity across California.

The Lassen County region does not have any ITIP project priorities or funding requests for the 2024 cycle.

Looking forward, improvements to US 395 from east of Susanville to Reno are expected to be a high-priority for the region, and may be a candidate ITIP project.

LCTC Qualitative Assessment

The LCTC has used the following performance measures in developing the 2024 RTIP: Congestion Reduction, Infrastructure Condition and Safety.

- Congestions Reduction: Data such as vehicles miles travelled per capita, area, by facility ownership and/or local vs tourist in not maintained in Lassen County. Mobility is measured based on Level of Service (LOS) on roadways within the region.
- 2. Infrastructure Condition: in keeping with the State of California's efforts to "fix it first" preserving the existing road system remains a high priority in the Regional Transportation Plan. The City of Susanville and Lassen County have few viable options when it comes to rehabilitating deteriorated roadways. For these agencies, the RTIP is the best funding option at this time. Roadways that carry a significant level of traffic continue to deteriorate throughout the region. While there will probably always be a need for one or two capacity increasing projects within the region, the need for preserving the existing roadway system is equally as great. Seven of the nine projects being promoted in the 2024 RTIP will improve the condition of regional roadways.
- 3. Safety: Safety is monitored through the accident rate (accidents per million vehicle miles of travel) for State highways. Lassen County does not keep accident rates on County roads within the region primarily due to a lack of comprehensive traffic count data. The LCTC continues to make substantial progress toward completing counts on several roadways; however more counts are needed to have a comprehensive data set for the entire region. The majority of accidents in Lassen County occur on the State Highway

system. The 2024 RTIP contains Nine (9) projects that will help improve transportation/mobility safety in Lassen County including projects on the State Highway System.

Section 13. Regional and Statewide Benefits of RTIP

Implementing projects in the 2024 RTIP for Lassen County will achieve the following regional and interregional transportation benefits.

- Provide improved access to and from primary employment centers and locations of regional importance via SR 36 and SR 139. Including:
 - Banner Lassen Medical Center
 - Lassen Community College
 - Susanville Municipal Airport
 - Diamond Mountain Casino and Hotel
 - Lassen High School
 - Lassen County Offices
 - City of Susanville City Hall
- Build upon a growing active transportation system by creating new Class I and II bicycle routes as well as sidewalks and pedestrian amenities connecting primary government, employment, and commercial centers.
- Reduce congestion and potential for accidents and delay.
- Improve system performance and reduce VMT to contribute to the emissions reductions targets desired for the region and the state.

Update LCTC Title VI and Public Participation Plan

REQUESTED ACTION: By Motion, adopt Resolution 21-15, adopting the Revised Public Participation and Title VI Plan as the Civil Rights (Title VI) Program for Lassen County Transportation Commission (LCTC)

BACKGROUND & DISCUSSION

LCTC is eligible to receive federal transportation funds. To this end LCTC is required to ensure that its services, activities and programs are distributed in an equitable manner; and conform to Title VI of the Civil Rights Act of 1964 as amended, as well as Presidential Executive Orders 12898 and 13166.

Title VI requires that no person in the United States, on the grounds of race, color or national origin be excluded from, be denied the benefits of, or be subjected to discrimination, under any program or activity receiving federal financial assistance. In furtherance of Title VI, Presidential Executive Orders 12898 addresses environmental justice in minority and low-income populations; and 13166 addresses services to those individuals with limited English proficiency.

At the September 16, 2019, Regular Meeting, the LCTC adopted its first Title VI and Public Participation Plan as a stand-alone agency. Title VI requires periodic updates to the document to address changes in applicable law and to reflect current methods of reaching the various stakeholder groups described therein.

Staff distributed the existing plan to Caltrans, the Technical Advisory Committee (TAC) and the Social Services Technical Advisory Committee (SSTAC) for review and suggest revisions. The revised document reflects all comments received, as well as updates needed to reflect changes in LCTC commissioner composition, staffing, critical dates, and to reflect changes in outreach tools and techniques not available in 2019.

RECOMMENDATIONS

Staff recommends that the Board accept as complete and adopt the attached LCTC Public Participation and Title VI Plan. The TAC concurs with this recommendation.
